*Victims of Crime and their families can receive free counseling at **Innovative Alternatives, Inc.***

*Crime victims, immediate family members and eye witnesses receive counseling at **NO CHARGE** by IA through a Victim of Crime Act grant awarded by the Texas Office of the Governor—Criminal Justice Division. Reporting to the police is not required.*

*Crime Victims Compensation is available at **NO CHARGE** to clients who filed police charges in response to a victimization that occurred within the last 3 years. CVC allows for continuation of treatment following exhaustion of IA grant benefits.*

A crime may last only a few moments, but its impact may be felt for a lifetime. Victims of Crime feel hopelessness, fear, and loss of control. Managing these symptoms and rebuilding your life can be difficult and costly.

IA provides 8 **FREE individual therapy sessions** to any crime victim, immediate family member and/or eye witness of any crime-**regardless** of when the crime occurred and whether or not it was reported to authorities. **Eighteen hours total of FREE group counseling, psycho-educational classes and/or advocacy are also available to crime victims.**

IA's Crime Victim Advocate will help navigate and assist you through the confusing network of the Texas Crime Victims Compensation system which may cover the cost of additional services.

Education and Independence through Training

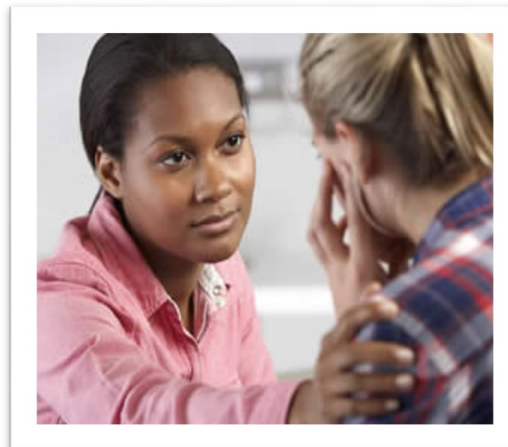
IA provides education and training through group therapy and/or professional training. Both are free to qualifying victims, family members and witnesses. Topics include:
